

Know Your Enemy

Prior to the "pandemic" it was widely assumed by the general public that governments had their best interests at heart, because governments were elected to represent their interests. However, the behaviour of governments during the pandemic has greatly eroded this trust.

Evidence that the Covid 19 was engineered to make an ordinary corona virus infectious for humans is suggested by the evidence described in this article. Such engineering reveals deliberation and intent to harm on the part of western governments, regulatory authorities and pharma. Dr Bean on the Effects of MSH3

The inserted sequence is homologous to a DNA repair protein called MSH3. Dr Bean has demonstrated the MSH3 is critical for human DNA repair, yet the inserted sequence codes for a protein that is homologous to it, and so will result in dysregulation of DNA repair.

The Importance of Continuous Repair

Each moment of every day our DNA is assailed by conditions that require an efficient DNA repair system to ensure that damage does not accumulate or multiply. Repair must operate continuously.
